This letter is to inform you of the requirements for taking the North American Veterinary Licensing Examination.

All NAVLE candidates must apply for the NAVLE through a state or provincial licensing board, and each jurisdiction sets its own eligibility requirements for the examination. If you do not plan to be licensed in Mississippi, please go to <https://www.icva.net/licensing-boards/> to find the requirements for the jurisdiction in which you would like to be licensed.

If you choose to take NAVLE through Mississippi, please complete the following steps:

1. Complete an Application for Certification of NAVLE Eligibility and State Examination for License in its entirety and
2. Pay the state testing fee of \$200.00. (This \$200.00 fee is a one-time non-refundable fee. It includes your testing fee and license fee for one year.)
3. Include a passport size and quality photo. The photo must be passport size, printed on photo paper, and printed on a laser jet printer so that it will not fade over time. This is part of your permanent record in our office.

Your completed application and attachments must be returned to the Mississippi Board of Veterinary Medicine by August 1, 2023.

If you choose to drop off your application and we are out of the office, there is a receptacle beside the door where you may leave your application and attachments.

Our office is located at 1089D Stark Rd. This is between the Social Security Office and the old Rick's Furniture building. The sign out front says First South Farm Credit. Our office is on the right side of the building.

After registration ICVS will send you information regarding your test dates. If you register through Mississippi, you do not have to take the test in Mississippi. If you are out of state during the testing window you may take the NAVLE at any approved testing site.
